The above named dog is being sold as a **Pet (Limited AKC Registration)** for the sum of \$\_\_\_\_\_. A deposit of \$500.00 must be paid to hold the above puppy and is **NON REFUNDABLE**. Purchase price is also **NON REFUNDABLE**. See below for further details to this sale.

### BREEDER AGREES:

- Above puppy has been found to be in good health.
- Above puppy is up to date on its immunizations and dewormed.
- Above puppy has been vet checked with no concerns found.
- To have AKC forward papers directly to buyer.

At the time of sale, this dog/puppy is considered and being sold as pet quality.

### **72 Hour Health Guarantee: (3 year replacement guarantee)**

This puppy is guaranteed to be in good health at the time of delivery. The buyer agrees to have the puppy inspected by a licensed veterinarian within 72 hours of pickup (excluding Sundays and Holidays). If the puppy is found to be in unacceptable health, a written statement from the veterinarian should be forwarded to the seller and the puppy should be returned within 72 hours (at buyer's expense) for a replacement.

**If at any time in the first 72 hours the buyer regrets purchasing the puppy the puppy may be returned to the seller for a refund of the purchase price (minus the non-refundable deposit) as long as the puppy is returned in good health. If the seller incurs any vet bills due to the condition the puppy is returned in then those will be deducted from the refund.**

### BUYER AGREES:

- Puppy must be paid in full at the time of pick up.
- To have above puppy vet checked within 72 hours of pickup.
- **This dog is not to be used for breeding under any circumstances. Any breeding, even accidental, voids all guarantees.**
- To notify the breeder if they can no longer care for the puppy/dog, puppy/dog will be returned to the breeder at no cost to the breeder. **This puppy cannot be transferred to a third party without written consent from the breeder.**
- This contract applies to the original buyer only and is non-transferable to a second party.
- Buyer agrees to inform breeder of any health issues that might arise in said puppy so breeder can work to eliminate them from the breed. Buyer agrees to forward vet statements to the breeder explaining these health issues within 30 days of diagnosis.
- If the puppy should pass away for any reason an autopsy **MUST** be performed at buyer's expense and results forwarded to breeder within 15 days.

### TERMS OF REPLACEMENT:

If the above dog should develop a severe genetic disease before it's third birthday and can no longer function as a Pet/Companion Animal the breeder will replace at no charge with a comparable puppy. The dog will be replaced either from the same litter or from a future litter. A letter from the vet stating the problem found and the vet's opinion on the viability of the animal must be sent to the seller within 15 days of diagnosis. The seller will have the final say on

whether the original puppy must be returned. All the vet bills and returned shipping fees are the responsibility of the buyer.

**This health guarantee is void if the puppy has had its gonads (testes or ovaries) removed prior to its first birthday. Vasectomies and hysterectomies (commonly called Ovary-Sparing Spays) may be done prior to that time for birth control reasons (if desired).**

This guarantee does not include uneven bites, un-dropped testicles, or umbilical hernia.

All vet bills for the puppy – including but not limited to corrective surgery, cosmetic surgery, shots and normal health care, euthanasia, spay/neuter and also all shipping or transport requirements are the responsibility of the buyer.

Buyer understands that no breeding rights are being sold with this puppy, breeder retains all breeding rights to this puppy and should this dog be accidentally bred, all resulting offspring are owned by Cadogans Boxers. There is a penalty of \$1000 for each unauthorized puppy produced by this dog, payable by buyer to Cadogans boxers immediately upon birth.
